Feis representatives will be available during setup to assist you to your reserved location. We ask you to stay until at least 5pm on Saturday. All vendor spaces must be clear by 8pm Saturday.

SPECIAL REQUIREMENTS: Vendors with special requirements, such as access to electrical outlets, must be sure to indicate those requirements on the Vendor Application. Vendors who make special requests at set-up time may not be accommodated.

ACCEPTANCE: Vendor applications will be accepted until 29 May 2018, or until allocated vendor space is full. The Pike's Peak Feis reserves the right to refuse any application. Applicants that have been refused due to a lack of available space or excessive overlap in merchandise (e.g., four vendors selling same brand of hard shoes), will be placed on a waiting list in order of application receipt. The vendor will be contacted should a space become available. Letters of confirmation will be mailed in early May with feis admissions and a complete list of accepted vendors. Applications that were not accepted will be returned with a full refund.

CANCELLATIONS: If a Vendor decides to cancel an application, the Pike's Peak Feis Committee must be notified, in writing, **no later than 29 May 2018**. All funds will be returned

SECURITY: The middle school building will be locked and alarmed immediately after each day's events. After-hours access is not expected but no physical security (security guards) will be provided. The Pike's Peak Feis, Saint Brendan's Irish Dance Foundation, Academy School District 20 and/or Eagleview Middle School cannot take responsibility for lost or stolen merchandise.

LIABILITY: We strongly encourage you to have liability coverage for yourself and anyone who might be shopping or working at your vendor site. The Pike's Peak Feis, Saint Brendan's Irish Dance Foundation, Academy School District 20 and/or Eagleview Middle School cannot take responsibility for accidents that may occur within your vendor space(s).

CONCESSIONS: The school food court may be open during the feis, providing snacks, lunch items, and hot and cold drinks. Eagleview Middle School is located within walking distance of restaurants, grocery stores but please feel free to bring your own lunch. *No alcohol, please.*
